

OCEANIC DIVER OF THE MONTH!

HOW TO ENTER:

Simply email a picture of yourself to anna@oceanicaus.com.au, above or below water fully kitted out in Oceanic gear!

All entries will be uploaded to an "Entries for Diver of the Month" album on our facebook page.

Photos must be of high resolution and with a short caption about where you are diving and what oceanic gear you have on at the time of the dive.

Applicants can enter a photo for every month of the competition but can only win Diver of the Month ONCE.

Diver of the Month competition runs for 12 months from August 2011 to July 2012.

Diver of the Month and Diver of the Year will be drawn by Oceanic Diving Australia.

PRIZES:

"Oceanic Diver of the Month" will receive a monthly prize, have their photo published in Dive Log magazine, as well be in the draw for the "Oceanic Diver of the Year" prize.

"Oceanic Diver of the Year" will win a fabulous 7 night dive package for 2 people at Bokissa Island Resort in Vanuatu, including 7 nights accommodation, all meals, 10 dive trips, return airfares and transfers! The winning photo will also be published on the front cover of DiveLog! The best photo will be selected by Oceanic Diving Australia from the 12 monthly winners. Flights are made from Sydney international airport and must be booked 2 months prior to travelling. Winner must notify Oceanic Australia 2months in advance to book flights and notify Bokissa Island Resort. Bokissa 7day dive package is valid for 18months from the drawing of prize.
